In addition to fine assessed for a violation there will be a one-time \$60.00 court processing fee.

Any civil violations, not specifically listed in the schedule of fines and fees, may carry a fine of not less than \$50.00 or more than \$1,000.00 at the discretion of the Tribal Court plus the one-time \$60.00 court processing fee.

Any Criminal offenses/violations, not specifically listed in the Schedule of fines and fees, may carry a fine of not less than \$200.00 or more than \$5,000.00 plus the \$60.00 court processing fee, and may include a jail sentence of up to 365 days at the discretion of the court.
